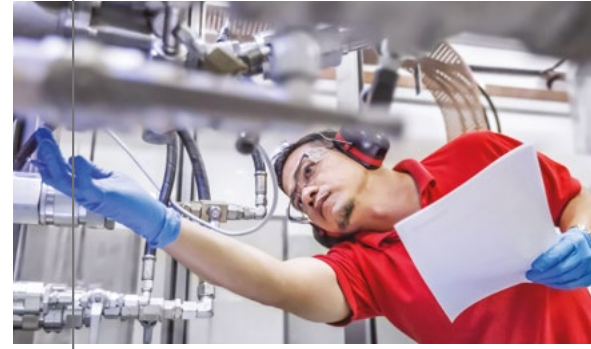


OCCUPATIONAL SAFETY & HEALTH AND ENVIRONMENT POLICY

It is therefore our policy to assure the OSHE integrity of our processes and facilities at all times and we strive to continually improve in providing safer workplaces and reducing our environmental footprint. Absolute compliance to standards, relevant laws and binding obligations is mandatory.

- ▶ We believe that if we are successful in managing and improving occupational safety, health and environmental matters, quality, delivery and cost will follow through the application of lean Continuous Improvement by all our employees.
- ▶ Through hazard identification and removal, all accidents are preventable and environmental impacts can be minimized.
- ▶ Occupational safety & health and environmental protection are everyone's responsibility. Through education and training everyone is enabled to fulfill the part expected of their role and function.

THE **CORE ELEMENTS** OF OUR APPROACH TO OCCUPATIONAL SAFETY & HEALTH AND ENVIRONMENTAL PROTECTION ARE:

› **Safe Systems of Work**

We examine the work performed at SR Technics systematically to identify potential hazards to the safety and health of our employees. To prevent accidents and health impacts or minimize the frequency and impact thereof we follow the risk control hierarchy (elimination, substitution, engineering / technical solution, administrative / organizational control, Personal Protective Equipment).

› **Stakeholder Involvement**

To address OSHE aspects that may be of concern and ensure that we initiate sustainable measures supported by those affected, we identify, involve and communicate with the relevant stakeholders.

› **Sustainable Resource Consumption**

We accept that our activities have an impact on the environment we operate and live in, beginning with the resources we need. We aim to reduce the amount of resources needed in our processes and strive to minimize emissions to the air, land or water through use of cleaner technologies and the safer use of chemicals.

› **Safe treatment of Waste**

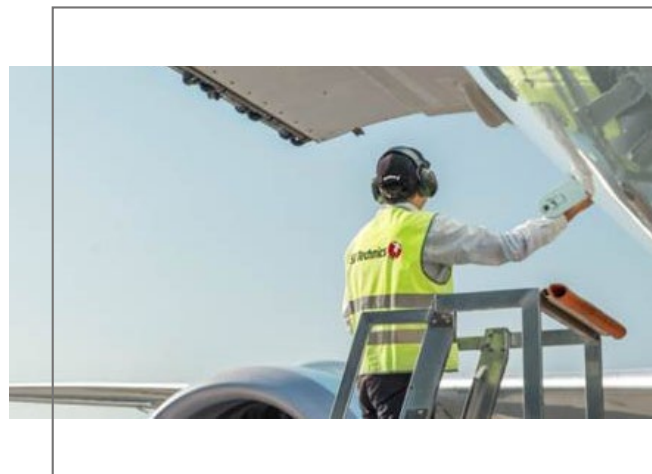

› **Reporting and Problem Solving**

To mitigate the inherent risk and prevent reoccurrence, we investigate reported accidents, incidents and near misses as part of our safety culture.

› **Emergency Preparedness and Response**

We recognize the possibility of emergencies happening. We therefore have built up and maintain an emergency response organization.
